The March for Life is a day trip to Chicago on January 13, 2019 via chartered coach bus to Federal Plaza in Chicago where you will join thousands of pro-lifers walking in defense of the preborn. Pro-Life Wisconsin provides dozens of pickup sites throughout the state and anticipates more sites being added to provide more Wisconsinites the opportunity of joining in on this March! The March itself is from 2 p.m. - 4 p.m.

Cost: \$30 per person / \$85 for family of 3 or more

Details: Join fellow pro-lifers on this growing March for Life in Chicago. Times listed below are 30 min before coach bus leaves, so please arrive at that time to ensure safe and easy boarding. Participants are responsible for packing a lunch for the ride down to Chicago but no glass containers are allowed. There will be a stop on the return trip to get dinner. Babies on laps are free. Anyone under 18 must be accompanied by an adult. There are no tickets for this event. Just show up if you have registered, you are on the bus list. PLW signs will be provided but feel free to create or bring your own if you'd like.
